The Acquisition of Genie Gateway by WWAG Creates a Unique Payment Gateway

(**OTCBB: WWAG**), parent of Summit Digital, Inc., a provider of cable television, high speed internet and related services to rural U.S. communities, announced today the completion of their Stock Exchange Agreement, in which WWAG has acquired 100% of AllCom's subsidiary, Genie Gateway.

In the near future, WWAG plans to file the necessary documents and applications to change its name to Genie Gateway, and to change its stock-trading symbol to one more synergistic with the company's new corporate name. Tom Nix, president of Summit Digital, Inc., WWAG's wholly owned cable TV subsidiary, commented, "Our subscribers will now be able to enjoy their cable TV as well as conduct business with anyone directly from their cable TV, in person, by phone, by email, over the internet using any web enabled device. And, this will be the first time where cable TV, high speed Internet and wireless Internet service providers will actually be in position to offer merchants and advertisers a way to complete a sale for their goods and services when advertised, and get paid in real-time, anytime 24x7x365."

Thomas E. Skala, CEO of Genie Gateway parent AllCom, stated "We believe Genie Gateway's Unified Phone Number ("UPN") solution will be a major game changer in the transaction processing world -- it's like being able to

conduct business in multiple parallel universes simultaneously. The UPN is not a credit card and it's not a debit card, it is a phone number that can facilitate secure peer-to-peer, real-time cash payments. When using UPN on the telephone, online, or in a retail environment, the purchase is treated as a traditional cash purchase, but with the payment processed as an electronic credit".

Mr. Skala continued, "WWA Group intends to leverage this new technology to enhance its existing plan to consolidate the fragmented wireless broadband marketplace. Genie Gateway allows subscribers to make payments to, and accept payments from, third parties, online or by phone. Payments are processed electronically as peer-to-peer, cash transactions, and are not subject to traditional credit card merchant processing rules and regulations".

Tom Nix, president of Summit Digital, Inc., said that "Our plans are to introduce and advertise Genie Gateway jointly with other cable television, high speed Internet and wireless Internet service providers (WISP's) to their subscribers, on their respective systems as the next generation of unified services while creating a new way to build additional high margin revenues."

Advising on the transaction was Source Capital Group, Inc., a Westport, CT-based boutique investment banking firm focused on technology, communications, clean energy, and emerging growth companies.
